

Privacy Policy- Export

Euroband B.V. highly values the protection of your personal information. In this Privacy policy we aim to provide clear and transparent information about how we handle personal information.

We do everything to safeguard your privacy and therefore handle personal information carefully. Euroband B.V. always complies with the applicable laws and legislation, including the General Data Protection Regulation. This includes that we do the following:

- We process your personal information in accordance with the purpose for which it has been provided, these purposes and personal information type is described in this Privacy policy;
- Processing your personal information is limited to only that information which is required as a minimum for the purposes for which it is processed;
- We ask for your express permission whenever we need this for processing your personal information;
- We have taken suitable technical and organisational actions to safeguard the security of your personal information;
- We do not transfer personal information to other parties, unless this is necessary to execute the purposes for which it was provided;
- We are aware of your rights when it comes to your personal information, want to point them out to you and respect them.

As Euroband B.V., we are responsible for processing your personal information. If, after going through our Privacy policy, or in general, have any questions about this or wish to contact us then this is possible using the contact information at the bottom of this document.

Processing of personal information of Customers

Personal information of customers or suppliers are processed by Euroband B.V. for the following purpose(s):

- Administrative purpose;
- Communication about the assignment and/or invitations;
- Executing or issuing an assignment.

Basis for this personal information is:

- The agreed upon assignment.

For the abovementioned purpose(s), Euroband B.V. may request the following personal information from you:

- Name;
- Surname prefix;
- Surname;
- (Business) Telephone Number;
- (Business) Email address;
- Gender;
- Business information;
- Chamber of Commerce information (if available).

Your personal information is saved by Euroband B.V. for the purpose of the abovementioned processing(s) for the period:

- During the duration of the agreement and afterwards only in the financial administration for a maximum of 7 years.

Providing to third parties

The information which you provide to us can be provided by us to third parties if this is necessary to execute the purposes described above.

For example, we make use of a third party for:

- Taking care of the internet environment for the GDPR program;
- Handling the (financial) administration;
- Stating information of the sold tyres to the RecyBEM (Car Tyres (Management) Decree).

We never give personal information to other parties with whom we have not concluded a processing agreement. With these parties (processors) we make the necessary agreements to safeguard the security of your personal information. Furthermore, we will not provide the information provided by you to other parties, unless this is required and permitted by law. An example of this would be if the police would request (personal) information from us in the context of an investigation. In such a case we are required to cooperate and we are therefore obligated to provide this information. We can also share personal information with third parties if you give us written permission to do so.

With the EU

We do not provide personal information to parties located outside of the EU.

Minors

We only process personal information of minors (persons younger than 16 years old) if given written permission in advance by the parent, caretaker or legal representative.

Retention period

Euroband B.V. does not store personal information for longer than necessary for the purpose for which it was provided or required by virtue of the law.

Security

We have taken suitable technical and organisational actions to protect personal information against unlawful processing, including the following actions;

- All persons who can take note of your information on behalf of Euroband B.V. are bound to its confidentiality.
- We use a username and password policy on all our systems;
- We pseudonymize and ensure the encryption of personal information if there is reason to do so;
- We make back-ups of personal information in order to recover this in case of physical or technical incidents;
- We regularly test and evaluate our actions;
- Our employees have been informed about the importance of the protection of personal information.

Rights regarding your information

You have the right of inspection, rectification or removal of the personal information which we have received from you. In addition, you can object against the processing of your personal information (or a part thereof) by us or one of our processors. You also have the right to have the information provided by you to us to yourself or directly to another party by your order. We may ask you to identify yourself before we can act on the aforementioned requests.

If we are allowed to process your personal information on the basis of a permission given by you for this purpose, then you always have the right to withdraw this permission.

Complaints

If you have a complaint about the processing of your personal information, then we kindly request that you contact us directly. If we do not reach a solution together, then this is of course very unpleasant. You always have the right to submit a complaint to the Dutch Data Protection Authority, this is the supervisory authority in the field of privacy protection.
